

The following is a correspondence that I recently received from "Mr. Jack Popejoy" a radio personality of KFWB Radio in Los Angeles. Moreover, I am posting it exactly as I received it.

Get me off your website NOW, or I'm suing you. This is libelous, slanderous, untrue, dishonest, false, and a deliberate lie. You are SCUM!

Stop it NOW, or else!!!! "

I would really like to make a comment on the "veiled threat" I have received here, but there simply is not one. This is a written threat as you can plainly see and easily review. Yet, there is no claim of, nor mention of, damages of any kind. ABSOLUTELY NONE! No damage at all, or what so ever; either actual or perceived, and that is quite simply because there isn't any.

And that admittedly, is because of my very obscure website: <http://www.caecus-fidelis.com>.

Caecus Fidelis - is Latin for "Sightless and Faithful" or it can be loosely translated as "Blind Faith." Moreover, Latin is not a common vernacular of everyday use. Nevertheless, Mr. Popejoy references that I have made a deliberate lie. But what exactly is Mr. Popejoy referring to? ... A search of "Mr. Popejoy" or "Jack Popejoy" on the Google website. One of today's largest known search engine databases. Did not associate and/or link him and/or his employer CBS Radio, with and/or to my website. Not on any of the 15 PLUS pages Google initially rendered. In fact it only referenced "Mr. Popejoy" when I typed in the name of my book "The Non Judicial Parent" + "Caecus Fidelis" + "Mr. Jack Popejoy." I wish to believe Mr. Popejoy is under the impression that the mere mention of his name, AS A RECIPIENT OF MY BOOK is worthy of his concern. Alternatively, perhaps Mr. Popejoy feels that his celebrity status narcissistic as it appears to be has done something to promote or even propel my book into a significant spotlight?

Quite the contrary, to be exact. To date I have self published over 600 copies of my book "The Non Judicial Parent" all at my own personal expense. I have formed a legal corporation, operating within the State of California to develop this venture, all at my own personal expense as well. I have personally sent at least 280 of those books to various Professionals in Education, as well as Executive, Legislative, and Media Personalities. Hoping someone would at the very least, dutifully investigate what they might have read. In short, the answer is "Not even the slightest indication of interest."

That promotion... And the hope that weighed upon it was a colossal failure. And it carried a very hefty price tag for me too. At that particular time, was roughly twenty-two thousand dollars out of my own pocket. All with no contributions from anyone, with no donations asked for or accepted and with no pleas for help to friends or family. It all fell to me, and whatever I could do to meet the demands and the overwhelming ~~costs~~ sacrifices involved. To date, I have received several well-meaning phone calls from other parents undergoing a similar situation, but there has been very little by way of offset towards my expenses.

I delivered several copies of a manuscript that I published to the address listed for contact of various Radio Personalities at KFWB. [In-fact I have sent several copies of my book to as many STATE and FEDERAL LEGISLATURE and PUBLIC TELEVISION/RADIO PERSONALITIES that I could afford too.](#) I have even sent copies of my book to the American Civil Liberties Union (ACLU) on both the East and the West coast for their review. Although I must admit, that it came as no great surprise. When all the books that I sent to an Officially listed ACLU Organizational address in Washington D.C., were returned un-opened and un-read. Along with their affixed posted return delivery confirmation too.

I have even sent copies of this very same manuscript to the Office of the Governor, for both [California](#) and [Florida](#). Both Offices sent official return correspondence, encouraging me in a nicely written letters. [A letter from the Governor of California wishing me "Good Luck" and applauding me for my enthusiasm and dedication to the State.](#) My manuscript was written for other parents. To show what roadblocks will be thrown in your way. And what could very well happen to you, if you discover "Kiddie Porn" within your child's computer. Identifying what you thought

would be done. Identifying what you hoped would be done. And by reporting what was actually done.

Who wouldn't want to protect a child from the dangers associated and attributed with child pornography? Or from the perceived dangers to a child, from someone who views child pornography? Alternatively, and worst yet, who acts upon those sickened desires? However, having my worst fears confirmed, AFTER My daughter has been molested. Is not something that is going to make me sleep better at night!

MY BOOK "THE NON JUDICIAL PAENT" DESCRIBES MY LEGAL FIGHT, AND MY EVERY EFFORT TO PROTECT MY CHILD FROM A VERY REAL AND TERRIFYING THREAT. RUNNING THROUGH EVERY ROADBLOCK IMAGINED AND DISTINGUISHED. AND ALL AFTER FINDING SEVERAL SAVED PAGES OF KIDDIE PORNOGRAPHY SECURED UPON MY DAUGHTERS' COMPUTER. AND ALL AS A NON-CUSTODIAL PARENT, LIVING IN CALIFORNIA WHILE HAVING A DAUGHTER WHO LIVES WITH HER CUSTODIAL PARENT IN FLORIDA.

My website <http://www.caecus-fidelis.com> clearly identifies this agenda, on each and every page. In addition, you have to scroll through the pages to review the "untrue [?]" information that Mr. Popejoy is referencing. Therefore, the burning question to me at least, really comes down to this... Did he actually read the book? On the other hand, did someone who read it previously ask him a question about the book? And since I personally delivered copies of this book to the KFWB lobby in December of 2007, why wait so long (Well over a year) to contact me? Granted when I first started this, I understood that my initial concern for my child, and saddening possibly when related to other children. Nor that my personal agenda would be something that is shared by everyone. Moreover, I soon and very clearly understood that as a non-custodial parent, I just might be all alone in this.

However, being called "Scum" for taking a stand against Child pornography.... WOW!

Let me make this perfectly clear for anyone and everyone reading this brief... Myself, My book, "The Non Judicial Parent," and my subsequent website: <http://www.caecus-fidelis.com>. Are, have always been, and will always be. Clearly identified as being completely and unwaveringly against such an unconscionable filth, against such a contemptible sickness, that is child pornography. And this unequivocal and it shall never be subject to the "free interpretation" or "false witness" of anyone, at anytime ever. This philosophy has been such from my initial awareness of such things in existence, and will be deeply entrenched such until the end of my days.

Well, since Mr. Popejoy took the apparent time to write his remarkably fatuous and intellectually veiled threat. And subsequently send that threat to me after reviewing my website, and thus retrieving my business e-mail address...

Well I have decided to post any and all future correspondence relating to my plight. To my fight against child pornography and my efforts to protect children from such filth. I have posted for review below, my return mailing to Mr. Popejoy. Moreover, I wish him nothing but continued success in his own fight. His personal fight, battling against the issues of child pornography on his own terms and in his own way.

I will post all of this in it's entirety on every website I can. And the following page is the reply that I will send to Mr. Popejoy...

Dear Mr. Popejoy;

I personally delivered several copies of my book to the address of 5670 Wilshire Blvd. In Los Angeles, CA, on December 21, 2007. I delivered these books in two medium sized, and open for inspection, cardboard boxes. Each copy of my manuscript, individually addressed to each and every reporting personality listed on the 980 KFWB Website.

Each book was separately enclosed while displaying individually addressed recipients, in a protectively large envelope. A "media" manila, type envelope that was padded with bubble wrap on the insides and clearly labeled for delivery on the outside, with my return address affixed to each addressed envelope should they not be accepted.

I attempted to give these boxes to a pleasant and impeccably dressed receptionist in the entrance lobby. A receptionist who immediately directed me to place the books on a counter-top located to her immediate left side, and slightly behind her. Seemingly under a wide staircase at the address of: 5670 Wilshire Blvd., Los Angeles, CA. A counter-top/shelf/bench-top under a wide staircase if I may add, which contained many previously deposited, but yet to be delivered items easily identified as being from both UPS and FedEx as well.

I must take the time however; to thank you for your timely reply. You might have simply begun your e-mail by simply stating that this is not the type of news you report upon. Then perhaps, professionally directed me to yet another individual who might render this particular type of reporting, or that might have an interest in reporting upon such things.

Nothing on my website implicates you and/or your employer, CBS Radio; to and/or with, any illegal activity. Nor does it even begin to imply the personal and/or professional endorsements, of you and/or your employer CBS Radio; with the subject matter contained within "The Non Judicial Parent" in any way, shape, or form.

All my website identifies, is very specifically whom I have personally delivered and/or sent copies of my manuscript to, and at which specific date. All of which are now totaling over roughly \$54000.00. And all of which have been carried over two printing editions, the forming of a publication company, and countless other expenses that have all been monetarily all encompassing... and all like I have said, completely out of my own pocket and without any regrets what-so-ever. That is all, but that was well over 438 Days ago. Or if you prefer: It has been 1 Year, 2 Months and 10 Days that time has elapsed, as indentified by your emotional and fatuously threatening e-mail. Since my initial and only delivery addressed to you, and one that I personally delivered to: 5670 Wilshire Blvd., Los Angeles, CA. [And only now, do you feel you have cause to send me a documented threat via traceable e-mail?](#)
